Bylaw No. 2657

WATER SHORTAGE RESPONSE PLAN BYLAW

WHEREAS there is a desire to provide an effective method of water conservation within the City and to cooperate with the Greater Vancouver Water District to regulate the use of water supplied for outdoor uses;

AND WHEREAS pursuant to section 8(2) of the Community Charter, S.B.C., 2003, c 26, as amended, Council has the authority by bylaw, to establish and regulate a service to all or part of the City;

NOW THEREFORE, the Council of the City of Port Moody, in open session assembled, enacts as follows:

1. CITATION

This Bylaw may be cited as the "Water Shortage Response Plan Bylaw No. 2657".

2. DEFINITIONS AND INTERPRETATION

In this Bylaw:

- (a) "Automatic Shut-off Device" means a device attached to a water hose that is spring loaded and shuts off the supply of water automatically unless hand pressure is applied to allow the supply of water.
- (b) "City" means the City of Port Moody".
- (c) "City Engineer" means the Director of Engineering, Parks & Operations and shall include the duly authorized designate.
- (d) "Commissioner" means the Commissioner of the Greater Vancouver Water District.
- (e) "Drip irrigation" means a system using irrigation components which consume less than 20 gallons (91 litres) per hour and operate at less than 25 PSI (172 kPa) to deliver Water to the root zone of the plant material being irrigated.

- (f) "Lawns" includes grass growing at cemeteries.
- (g) "Non Residential Address" means those addresses not zoned residential specifically, including mixed zoning or mixed use, where commercial or industrial uses are included on the same property along with residential, and the property is subject to the landscaping being watered by and in ground sprinkling system.
- (h) "Permit" means a permit issued under Part 5.
- (i) "Person" does not include a municipality, a regional district, the provincial government, or any body appointed or created under an enactment of Canada or British Columbia.
- (j) "Public Announcement" means one or more advertisements or public service announcements in any one of:
 - (i) a television or radio broadcast from a station that broadcasts to the City of Port Moody;
 - (ii) a newspaper or other publication intended for general circulation, including one that is distributed without charge to the reader, that contains news and advertising, and is distributed within the City of Port Moody at least once per week.
- (k) "Restriction Stage" means Stage 1 Restrictions, Stage 2 Restrictions, Stage 3 Restrictions, or Stage 4 Restrictions.
- (l) "Stage 1 Restrictions" means the restrictions on Water use described in sections 1.1 and 1.2 of Schedule 1.
- (m) "Stage 2 Restrictions" means the restrictions on Water use described in sections 2.1 and 2.2 of Schedule 1.
- (n) "Stage 3 Restrictions" means the restrictions on Water use described in sections 3.1 and 3.2 of Schedule 1.
- (o) "Stage 4 Restrictions" means the restrictions on Water use described in sections 4.1 and 4.2 of Schedule 1.
- (p) "Water" used as a noun means water supplied directly or indirectly by Greater Vancouver Water District or the City of Port Moody, whether or not mixed with rain water, gray water or recycled water.

- (q) “Water” used as a verb, and “Watering”, mean the application or distribution of Water (used as a noun) to lands or plants but does not include the method known as “drip irrigation”;
- (r) “Water Play Park” means a recreational facility that is primarily out of doors, that includes water slides longer than 10 meters;
- (s) “Water Restriction Announcement” means a Stage 1 Announcement, Stage 2 Announcement, a Stage 3 Announcement or a Stage 4 Announcement.
- (t) “Water Use Plan” means a Water Use Plan approved by the *City Engineer* for a golf course operation under Part 5.

The schedules to this bylaw are integral parts of this bylaw.

The City Engineer may delegate some or all of his or her powers and duties under this Bylaw.

3. DECLARATION AND ANNOUNCEMENT OF RESTRICTION STAGES

- 3.1 (a) The Commissioner may, by letter to the City, declare that the Greater Vancouver Water District has activated a Restriction Stage.
- (b) If the Commissioner makes a declaration under subsection (a), the Restriction Stage described in the declaration comes into force in the City seventy-two hours after the Commissioner or the City makes a Public Announcement of the declaration.
- (c) When a Restriction Stage comes into force under this section, a Restriction Stage that had been in force, if any, ceases to be in force.

- 3.2 If no Restriction Stage is in force on May 1th of any year, Stage 1 Restrictions come into force on that date without prior declaration of the Commissioner or announcement under section 3.3.
- 3.3 (a) If the Commissioner declares that the Greater Vancouver Water District has activated Stage 1 Restrictions, a Public Announcement by the City or the Commissioner is sufficient for the purposes of paragraph 3.1(b) if it contains substantially the information set out in Schedule “2”.
- (b) If the Commissioner declares that the Greater Vancouver Water District has activated Stage 2 Restrictions, a Public Announcement by the City or the Commissioner is sufficient for the purposes of paragraph 3.1(b) if it contains substantially the information set out in Schedule “3”.

- (c) If the Commissioner the Greater Vancouver Water District has activated Stage 3 Restrictions, a Public Announcement the City or the Commissioner is sufficient for the purposes of paragraph 3.1(b) if it contains substantially the information set out in Schedule “4”.
- (d) If the Commissioner the Greater Vancouver Water District has activated Stage 4 Restrictions, a Public Announcement by the City or the Commissioner is sufficient for the purposes of paragraph 3.1(b) if it contains substantially the information set out in Schedule “5”.

- Amended by BL3047 (b) At any time before or after October 15th of any year the Commissioner may, by letter to the City declare that notwithstanding subsection (a), a Restriction Stage will remain in force or come into force after September 30th.
- Amended by BL3047 (c) Subsections 3.1(b), 3.1 (c) and section 3.3 apply to a declaration made under this section, with such changes as are necessary, except that a Public Announcement of a declaration under this section shall state that the Restriction Stage that is continued in force or that comes into force after October 15th will remain in force until further declaration of the Commissioner.
- (d) The Commissioner may make one or more declarations under this section.

4. SPECIAL WATER USE PLANS

This section is not used.

5. PERMITS

- 5.1 A Person who has installed a new Lawn, either by placing sod or turf or by seeding, or who has installed new landscaping on a substantial part of the outdoor portion of a premises may apply to the City Engineer for a Permit authorizing the Person to Water the new Lawn and new landscaping when Stage 1 Restrictions or Stage 2 Restrictions are in force, at times specified in the Permit, at the premises described in the Permit, during the currency of the Permit. A Permit does not exempt the holder from Stage 3 Restrictions or Stage 4 Restrictions.
- 5.2 The City Engineer, upon being satisfied that an applicant qualifies under section 5.1, shall issue a Permit in the form set out in Schedule “6” to the applicant upon payment of a fee prescribed in the “City of Port Moody Fees Bylaw”.
- 5.3 A Permit issued under section 5.2 shall be affixed to a post facing the street serving the premises, beside the principal driveway from the street to the premises.
- 5.4 A Permit issued under section 5.2 shall expire and be of no force or effect 21 days after the date of its issue, unless the Person has been issued an extension under section 5.5.
- 5.5 Before or after the expiration of a Permit issued under section 5.2 a Person may apply for one extension of the Permit on the same terms and conditions as may be imposed under

section 5.2. Such an extension shall end on or before 42 days from the date of the issue of the Permit under section 5.2.

- 5.6 A person who has treated a lawn by applying nematodes that require additional watering outside of the allowable sprinkling restrictions may apply to the City Engineer for a Permit authorizing the Person to Water the affected area when Stage 1 Restrictions or Stage 2 Restrictions are in force, at times specified in the Permit, at the premises described in the Permit, during the currency of the Permit. A Permit does not exempt the holder from Stage 3 Restrictions or Stage 4 Restrictions.
- 5.7 The City Engineer, upon being satisfied that an applicant qualifies under section 5.6, shall issue a Permit in the form set out in Schedule 7 to the applicant.
- 5.8 A Permit issued under section 5.6 shall be affixed to a post facing the street serving the premises, beside the principal driveway from the street to the premises.
- 5.9 A Permit issued under section 5.6 shall expire and be of no force or effect 14 days after the date of its issue.

6. OFFENCES AND PENALTIES

Every Person who violates or contravenes any of the provisions of this bylaw, or suffers or allows to be done any act or thing that violates or contravenes this bylaw, commits an offence under this bylaw punishable on summary conviction and is liable to the fines set out in sections 6.2 and 6.3.

Sections 6.2 and 6.3 deleted by Bylaw 2895

- 6.2 Subject to section 6.3, if a prosecution is commenced pursuant to section 6.2(b), upon conviction the offender shall be liable to pay a fine:
- (a) for a first conviction for an offence, of not more than \$10,000 and not less than \$3,000;
 - (b) for a second or subsequent conviction for an offence, of not more than \$10,000 and not less than \$5,000 for each offence.
- 6.3 Where a prosecution is commenced against a commercial entity pursuant to section 6.2(b) for an offence committed while Stage 4 restrictions are in effect, whether or not a Water Use Plan is in effect for the offender, upon conviction that Person shall be liable to pay a fine of not less than \$5,000.
- 6.4 Section 6.4(b) applies whether or not a second or subsequent conviction is for conduct that preceded the conduct that is the subject matter of the prosecution then before the court.
- 6.5 If an offence under this bylaw continues for more than one day, separate fines each not exceeding the maximum fine for that offence may be imposed for each day or part thereof in respect of which the offence occurs or continues.

6.6 In a prosecution under this Bylaw the onus of establishing an exemption under subsections 1.2, 2.2, or 3.2 of Schedule 1 lies on the Person claiming the exemption.

7. DATE OF COMING INTO FORCE

This Bylaw comes into force and takes effect on the date of its passing.

SCHEDULE 1

RESTRICTION STAGES

STAGE 1 RESTRICTIONS

1.1 When Stage 1 Restrictions are in force, no Person shall:

1.1.1 Water Lawns, except:

a) Residential Addresses

- i. at premises with even numbered civic addresses, on Wednesday and Saturday between the hours of 4:00 a.m. and 9:00 a.m.; and
- ii. at premises with odd numbered civic addresses, on Thursday and Sunday between the hours of 4:00 a.m. and 9:00 a.m.

b) Non-Residential Addresses

- i. at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and on Friday between the hours of 4:00 a.m. and 9:00 a.m.;
- ii. at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.; and on Friday between the hours of 4:00 a.m. and 9:00 a.m.

c) Government/Schools/Parks

- i. at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and on Friday between the hours of 4:00 a.m. and 9:00 a.m.;
- ii. at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.; and on Friday between the hours of 4:00 a.m. and 9:00 a.m.

1.1.2 Water residential trees, shrubs and flowers on any day, prior to 4 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation

1.1.3 Water non-residential trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

- 1.1.4 Water Government/Schools/Parks trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.
- 1.1.5 Use a hose providing water to wash boats or motor vehicles, unless the hose is equipped with an Automatic Shut-off Device.
- 1.1.6 Use any hose without an automatic shut-off device.
- 1.1.7 Allow water to unnecessarily run off on impermeable surfaces such as driveways, curbs, pathways, or gutters when watering lawns and plants.
- 1.1.8 Water artificial playing turf and outdoor tracks except for a health or safety reason.
- 1.1.9 Allow hoses and taps to run unnecessarily.
- 1.1.10 Allow faulty, leaking, or misdirected Irrigation Systems to operate.
- 1.1.11 Flush water mains.
- 1.1.12 Water soil-based playing fields prior to 7pm or after 9am, except if:
 - a) Watering newly over-seeded fields, in compliance with a local government permit.
 - b) Operating under an approved local government water management plan.
- 1.1.13 Water sand-based playing fields prior to 7pm or after 9am, except if:
 - a) Watering newly over-seeded fields, in compliance with a local government permit.
 - b) Operating under an approved local government water management plan.

1.2 Section 1.1 of this Schedule does not apply to:

- a) A person who waters Lawns or landscaping at premises described in a valid and subsisting Permit, provided the Person is and has been at all times in compliance with the Permit.

- b) Watering new lawns or lawns being treated for the European Chafer Beetle, outside restricted lawn watering times if in compliance with a local government permit.

STAGE 2 RESTRICTIONS

2.1 When Stage 2 Restrictions are in force, no Person shall:

2.1.1 Water Lawns, except:

a) Residential Addresses

- i. at premises with even numbered civic addresses, on Wednesday between the hours of 4:00 a.m. and 9:00 a.m.; and
- ii. at premises with odd numbered civic addresses, on Thursday between the hours of 4:00 a.m. and 9:00 a.m.

b) Non-Residential Addresses

- i. at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
- ii. at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

c) Government/Schools/Parks

- i. at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
- ii. at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

2.1.2. Water residential trees, shrubs and flowers on any day, prior to 4 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

2.1.3. Water non-residential trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

2.1.4. Water Government/Schools/Parks trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

2.1.5. Use a hose providing water to wash boats or motor vehicles, unless the hose is equipped with an Automatic Shut-off Device.

- 2.1.6. Use any hose without an automatic shut-off device.
- 2.1.7. Allow water to unnecessarily run off on impermeable surfaces such as driveways, curbs, pathways, or gutters when watering lawns and plants.
- 2.1.8. Water artificial playing turf and outdoor tracks except for a health or safety reason.
- 2.1.9. Allow hoses and taps to run unnecessarily.
- 2.1.10. Allow faulty, leaking, or misdirected Irrigation Systems to operate.
- 2.1.11. Flush water mains.
- 2.1.12. Water soil-based playing fields prior to 7pm or after 9am, except if:
 - a. Watering newly over-seeded fields, in compliance with a local government permit.
 - b. Operating under an approved local government water management plan.
- 2.1.13. Water sand-based playing fields prior to 7pm or after 9am, except if:
 - a. Watering newly over-seeded fields, in compliance with a local government permit.
 - b. Operating under an approved local government water management plan.
- 2.1.14. Wash impermeable surfaces, at a residential or non-residential property, except if:
 - a. For a health or safety reason.
 - b. Preparing a surface for painting or similar treatment.
 - c. Aesthetic cleaning by a commercial cleaning operation.

2.2 Section 2.1 of this Schedule does not apply to:

- a) A person who waters Lawns or landscaping at premises described in a valid and subsisting Permit, provided the Person is and has been at all times in compliance with the Permit.
- b) Watering new lawns or lawns being treated for the European Chafer Beetle, outside restricted lawn watering times if in compliance with a local government permit.

STAGE 3 RESTRICTIONS

3.1 When Stage 3 Restrictions are in force, no Person shall:

- 3.1.1 Water Lawns.
- 3.1.2 Water residential trees, shrubs and flowers on any day at any time unless using a handheld hose, water container, or drip irrigation.
- 3.1.3 Water non-residential trees, shrubs and flowers on any day at any time unless using a handheld hose, water container, or drip irrigation.
- 3.1.4 Water Government/Schools/Parks trees, shrubs and flowers on any day at any time unless using a handheld hose, water container, or drip irrigation.
- 3.1.5 Use a hose providing water to wash boats or motor vehicles, except to clean windows, lights, mirrors, licence plates, and boat engines for safety.
- 3.1.6 Use any hose without an automatic shut-off device.
- 3.1.7 Allow water to unnecessarily run off on impermeable surfaces such as driveways, curbs, pathways, or gutters when watering lawns and plants.
- 3.1.8 Water artificial playing turf and outdoor tracks except for a health or safety reason.
- 3.1.9 Allow hoses and taps to run unnecessarily.
- 3.1.10 Allow faulty, leaking, or misdirected Irrigation Systems to operate.
- 3.1.11 Flush water mains.
- 3.1.12 Water soil-based playing fields more than 3 days in a 7-day period from 7 pm to 9 am except if:
 - a) Watering newly over-seeded fields if in compliance with a local government permit
 - b) Operating under an approved local government water management plan
- 3.1.13 Water sand-based playing fields more than 5 days in a 7-day period from 7 pm to 9 am, except if:
 - a) Watering newly over-seeded fields, in compliance with a local government permit.
 - b) Operating under an approved local government water management plan.

- 3.1.14 Wash impermeable surfaces, at a residential or non-residential property, except if:
- a) For a health or safety reason.
 - b) Preparing a surface for painting or similar treatment by a commercial cleaning operation.
- 3.1.15 Top up or fill aesthetic water features.
- 3.1.16 Operate water play-park, except water play parks with user-activated switches.
- 3.1.17 Top up or fill pools and hot tubs, except for pools and hot tubs with a permit to operate in accordance with health authorities having jurisdiction over pool and hot tub regulation
- 3.1.18 Water new lawns or lawns being treated for the European Chafer Beetle (Local government permits issued in Stages 1 or 2 remain in effect until permit expires and no new permits issued or renewed).
- 3.1.19 Water golf courses (Fairways) except if operating under an approved local government water management plan.
- 3.1.20 Commercial vehicle wash, unless:
- a) A facility that installed an automatic vehicle wash system before November 1, 2017, is operating on a basic wash and rinse cycle only
 - b) A facility that installed an automatic vehicle wash system after November 1, 2017, is operating using a water recycling system that achieves a minimum 60% water recovery rate over the full wash cycle.
 - c) A hand wash and self-service facility, is operating using high-pressure wands or brushes that achieve a maximum flow rate of 11.4 litres per minute.

STAGE 4 RESTRICTIONS

4.1 When Stage 4 Restrictions are in force, no Person shall:

- 4.1.1 Water Lawns.
- 4.1.2 Water residential trees, shrubs and flowers on any day, at any time.
- 4.1.3 Water non-residential trees, shrubs and flowers on any day, at any time.
- 4.1.4 Water Government/Schools/Parks trees, shrubs and flowers on any day, at any time.
- 4.1.5 Use a hose providing water to wash boats or motor vehicles, except to clean windows, lights, mirrors, licence plates, and boat engines for safety.
- 4.1.6 Use any hose without an automatic shut-off device.
- 4.1.7 Allow water to unnecessarily run off on impermeable surfaces such as driveways, curbs, pathways, or gutters when watering lawns and plants.
- 4.1.8 Water artificial playing turf and outdoor tracks except for a health or safety reason.
- 4.1.9 Allow hoses and taps to run unnecessarily.
- 4.1.10 Allow faulty, leaking, or misdirected Irrigation Systems to operate.
- 4.1.11 Flush water mains.
- 4.1.12 Water soil-based playing field.
- 4.1.13 Water sand-based playing field.
- 4.1.14 Wash impermeable surfaces, except if ordered by a regulatory authority having jurisdiction for health or safety reasons.
- 4.1.15 Top up or fill aesthetic water features.
- 4.1.16 Operate water play-park.
- 4.1.17 Top up or fill pools and hot tubs.
- 4.1.18 Water new lawns or lawns being treated for the European Chafer Beetle and all local government permits issued for lawn watering are invalidated.
- 4.1.19 Water golf courses.
- 4.1.20 Commercial vehicle wash.

SCHEDULE 2

INFORMATION FOR PUBLIC ANNOUNCEMENT OF **STAGE 1**
RESTRICTIONS

A Public Announcement of Stage 1 Restrictions is sufficient for the purposes of section 1.1 of Schedule 1 of this Bylaw if it includes substantially the following information:

1. Residential Addresses

- i) at premises with even numbered civic addresses, on Wednesday between the hours of 4:00 a.m. and 9:00 a.m.; and
- ii) at premises with odd numbered civic addresses, on Thursday between the hours of 4:00 a.m. and 9:00 a.m.

2. Non-Residential Addresses

- i) at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
- ii) at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

3. Government/Schools/Parks

- i) at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
- ii) at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

4. Water residential trees, shrubs and flowers on any day, prior to 4 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

5. Water non-residential trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

SCHEDULE 3

**INFORMATION FOR PUBLIC ANNOUNCEMENT OF STAGE 2
RESTRICTIONS**

A Public Announcement of Stage 2 Restrictions is sufficient for the purposes of section 2.1 of Schedule 1 of this Bylaw if it includes substantially the following information:

1. Residential Addresses
 - i) at premises with even numbered civic addresses, on Wednesday between the hours of 4:00 a.m. and 9:00 a.m.; and
 - ii) at premises with odd numbered civic addresses, on Thursday between the hours of 4:00 a.m. and 9:00 a.m.

2. Non-Residential Addresses
 - i) at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
 - ii) at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

3. Government/Schools/Parks
 - i) at premises with even numbered civic addresses, on Monday between the hours of 1:00 a.m. and 6:00 a.m.; and
 - ii) at premises with odd numbered civic addresses, on Tuesday between the hours of 1:00 a.m. and 6:00 a.m.

4. Water residential trees, shrubs and flowers on any day, prior to 4 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

5. Water non-residential trees, shrubs and flowers on any day, prior to 1 am or after 9 am if using a sprinkler, but may water at any time if hand watering or using drip irrigation.

SCHEDULE 4

INFORMATION FOR PUBLIC ANNOUNCEMENT OF **STAGE 3
RESTRICTIONS**

A Public Announcement of Stage 3 Restrictions is sufficient for the purposes of section 3.1 of Schedule 1 of this Bylaw if it includes substantially the following information:

1. That lawn sprinkling is not allowed by homes or businesses, including using sprinklers for children's play.
2. Water residential or non-residential trees, shrubs and flowers on any day at any time unless using a handheld hose, water container, or drip irrigation.
3. That private (residential) pressure washing is prohibited, and that commercial hosing or pressure washing is only allowed for health, safety or preparing a surface for painting.
4. That ornamental fountains must be shut down.
5. That hand washing of vehicles and boats is restricted to features required for safety (windows, lights, licenses).
6. No washing a boat or motor vehicle other than at commercial car wash.
7. Top up or fill pools and hot tubs, except for pools and hot tubs with a permit to operate in accordance with health authorities having jurisdiction over pool and hot tub regulation.

SCHEDULE 5

**INFORMATION FOR PUBLIC ANNOUNCEMENT OF
STAGE 4 RESTRICTIONS**

A Public Announcement of Stage 4 Restrictions is sufficient for the purposes of section 3.3 of this Bylaw if it includes substantially the following information:

1. That lawn sprinkling by homes or businesses is prohibited, including using sprinklers for children's play.
2. That watering of residential and commercial gardens, shrubs, trees and flower beds by any method is prohibited.
3. That drip irrigation is prohibited.
4. That private and commercial hosing or pressure washing is prohibited except if ordered by a regulatory authority.
5. That washing of vehicles using any method is prohibited except for features required for safety (windows, lights, licenses), including at commercial car washes.
6. That ornamental fountains must be shut down.
7. That refilling of private, commercial and public garden ponds, ornamental fountains, hot-tubs and swimming pools is prohibited.
8. That the operation of Water Play Parks is prohibited.
