### **CITY DRAWING SUBMITTAL GUIDELINE -**

### **UTILITY NOTIFICATION SPECIFICATION NOTES**

THE FOLLOWING SHALL ACT AS A GUIDE TO CONSULTANTS/ENGINEERS FOR THE CITY REQUIREMENTS ON DRAWING SUBMITTALS. THE INFORMATION PROVIDED IS GENERAL AND MAY NEED TO BE AMENDED/ADDED TO FOR COMPLEX UTILITY WORKS AS NEEDED OR IDENTIFIED BY OTHERS.

### REFERENCE

- 1. WHEN PROPOSED WORKS ARE NEAR A THIRD-PARTY UTILITY OR REQUIRE CONNECTION TO A CITY OWNED UTILITY, THE CORRESPONDING SIGNATURE BLOCK AND NOTES MUST BE SHOWN ON THE DRAWING.
- 2. THE SIGNATURE BLOCKS MUST BE PLACED ON THE LOWER RIGHT HAND CORNER OF THE DRAWING. THE CONSTRUCTION NOTES MUST BE PLACED ON THE DRAWING, AT A SUITABLE LOCATION.
- 3. THE SIGNATURE BLOCKS SHOULD ACT AS A REMINDER TO THE CONTRACTOR TO CONTACT THE NECESSARY AGENCY IN ADVANCE OF THE WORK. ON THE RED-LINE DRAWING, CONTRACTORS MUST SIGN AND DATE THE SIGNATURE BLOCK TO CONFIRM THAT THEY HAVE NOTIFIED EACH UTILITY AS REQUIRED.
- 4. THE CONSULTANT IS REQUIRED TO INCLUDE THE NAME AND DATE (AS PER THE RED-LINE DRAWING) ON THE AS-BUILT DRAWING SUBMISSION TO THE CITY.

<u>CONSTRUCTION NOTES</u>- 1-6 TO BE INCLUDED ON THE SUBMITTED PROJECT DRAWINGS AS REQUIRED: 7-9 ARE MANDATORY

- A SITE INSPECTION MUST BE COMPLETED BY BC HYDRO FOR ALL WORKS IN THE VICINITY OF BC HYDRO INFRASTRUCTURE. CONTACT ERIN PETERSON AT BC HYDRO, AT 604-469-8830 AT LEAST 72 HOURS PRIOR TO CONSTRUCTION

CITY OF PORT MOODY OPERATIONS DIVISION IS TO BE CONTACTED AT THE START OF CONSTRUCTION AND PROVIDED WITH A SCHEDULE OF UTILITY WORKS, INCLUDING DETAILS OF DISRUPTION TO SERVICES, MAJOR WORKS, AND WORKS INVOLVING CITY INVOLVEMENT (WATER). THE CITY WILL COORDINATE INSPECTIONS AS NEEDED FOR ALL UTILITY CONNECTIONS, CROSSINGS AND WORKS IN THE VICINITY OF CITY UTILITIES. CONTACT THE CITY'S WORKS YARD AT 604-469-4574 AT LEAST 72 HOURS PRIOR TO CONSTRUCTION.
- 8. THE CITY DOES NOT PERMIT CONTRACTORS TO OPERATE VALVES WITHOUT AUTHORIZATION. CONTACT THE CITY'S OPERATIONS DIVISION AT 604-469-4574 AT LEAST 72 HOURS IN ADVANCE TO COORDINATE VALVE SHUTDOWN/TURN-ON.
- 9. A SITE INSPECTION MUST BE COMPLETED BY THE CITY OF PORT MOODY FOR ALL WATER UTILITY WORKS, INCLUDING BUT NOT LIMITED TO PRESSURE TESTING, CHLORINATION, FLUSHING, AND TIE-INS. CONTACT THE WATER QUALITY TECHNICIAN (BEN KINESHANKO) AT 604-469-4604 AT LEAST 72 HOURS PRIOR TO ANY OF THE ABOVE WORKS.
